

Airfoil Meeting Minutes

February 2016

The February meeting of the Coffee Airfoilers was held February 1st, 2016 at the St. Barnabas Episcopal church. Club president Don Cleveland called the meeting to order at 7:00 pm.

The financial report was presented by club treasurer Bonny Jenkins. A motion to approve the budget report was made, seconded and approved. Bonny also reported we have 55 paid members to date.

Old Business

Wireless Microphone Purchase. Don Cleveland. Don reported he and Ernie Miller will together select which system to purchase, based on the three systems previously under consideration, and the budgeted amount previously approved by the club members.

Airport Notification Letter. Don Cleveland. Don stated he and Harold Jackson met with Tullahoma Airport Director Jon Glass for approximately 1/2 hour last month. Mr. Glass signed the notification letter and the letter has been returned to the AMA.

FAA "drone" registration. Don Cleveland. This registration is required by the FAA for all remotely piloted vehicles, which includes ALL R/C aircraft. The official last date to register is: 19 Feb, 2016. As of the last information from the AMA website, registration or non-registration will have no effect on a modelers status with the AMA. AMA's position is that registration is " at the modeler's discretion".

Field Improvement. Don Cleveland. The two mounds of dirt at the north end of the paved runway are still too wet to spread. George Schmidt stated he will look into renting equipment to spread the dirt, when the weather permits.

Winter Banquet. 30 Jan, 2016. Don Cleveland. Don stated that approximately 45 club and family members attended the banquet at the Oasis Restaurant in Winchester. Gerry Ewell donated a large number of R/C goodies to the club, as he is scaling back his collection. The donated items were auctioned. \$405 was raised for the club, thanks to Gerry's generous donation!

New Business

Review of the Executive Board Meeting, 21 Jan, 2016. Don Cleveland, Bonny Jenkins, Paul Green.

- President Don Cleveland presented the 2016 schedule of events, and briefed the membership on each event. The schedule will become part of the 2016 CAF membership brochure. Don called for a motion to accept the schedule. A motion to approve was made and passed.

- Treasurer Bonny Jenkins passed copies of the 2016 budget to the members present. She then reviewed the budget line-by-line. Bonny further explained the changes from the 2015 budget.

- Secretary Paul Green reviewed the club's Five Year Plan, explaining the items selected for action and funding for 2016, and the items which will receive further study and/or discussion before action is taken. Further a new item, review and updating the club by-laws, has been added as an action item for 2016..

Open discussion for additional items of interest. Don Cleveland opened the floor to the membership for any additional new business to be considered. No items were presented.
